

**Town of Magnolia  
Regular Monthly Meeting  
September 11, 2018**

The meeting was held at the Magnolia Town Hall, 14729 W. County Road A, Evansville, WI 53536. Those in attendance were: Chairman Kurt Bartlett, Supervisors Ron Sloniker and Dave Olsen, Clerk/Treasurer Graceann Toberman, Jeramie Mielke patrolman from the Rock County Public Works, Don Rosa, Allan Guth and Deputy Raby from the Rock County Sheriff's Department.

Call to Order

Bartlett called the meeting to order at 7:05 p.m.

The Pledge of Allegiance was recited.

Approve Agenda

Add: Appoint a Town Board Member to the Planning and Zoning Committee.

Clerk's Report

The Clerk's report for August 14, 2018 was reviewed and will be filed for the record.

Treasurer's Report

The balance in the general account on August 31, 2018 was \$195,308.37. The report will be filed for audit.

Public Comment

Don Rosa told the board that he had trouble with the last burial in the Magnolia East Cemetery because of the extremely wet conditions. In the future if there are the same conditions Don Rosa will check with the funeral director about the possibility of postponing burials until the weather is better.

Zoning Change Petitions

A Planning and Zoning Hearing is set for September 13, 2018 to amend the Magnolia Zoning Ordinance Book to receive certification from the Department of Agriculture, Trade and Consumer Protection (DATCP) to participate with the Farmland Preservation program. There are also two other items on the agenda.

Highways and Bridges

Jeramie Mielke informed the board of the projects he is going to work on this fall. He will take care of brush and trees that are too close to the edge of the road on Cainville Road using a fecon head on an excavator. Motion by Bartlett, seconded by Sloniker, to pay \$24,937.65 for work done from 7/1/18 – 7/28/18 (\$3,000.00 in aids was deducted from the total bill for this month) and to pay the second half of the winter maintenance for 2018 of \$19,021.50. Motion passed.

Discuss Town Hall Parking Lot

Bartlett will check into this more and it will be included on the October agenda.

Discuss Building at West Magnolia Cemetery

Olsen measured the building and calculated cost estimates to repair it. He said it could cost \$500.00 for a new roof, plywood, fascia, drip edge and paint. David P. Olson, a neighbor to the cemetery, has offered to paint the building and the town board members will do the labor for the rest of the repairs later this fall.

Assessor's Contract

The board signed the new contract with Grota for 2018-2021 for \$5,800 per year.

Set Date for Budget Workshops

Workshops will be held on Thursday, October 11 and Thursday, October 25 both at 6:00 p.m.

Appoint Town Board Member to finish term of vacancy on Planning and Zoning Committee

Bartlett appointed Sloniker to fill the vacancy until May of 2019.

Agenda for next Month

Add adverse conditions at the cemetery.

Pay Bills

The checks were read before the board by Toberman.


Meeting adjourned.
